## TRAIL MONITORING PROGRAM


Year two of WRTC's Trail Monitoring Program was a success. This program uses specialized trail-counting equipment and software, and observations collected by volunteers to continuously assess use levels and traffic patterns on trails in the Wood River Valley. This data can be utilized by recreation managers to make informed decisions with maximized impact on improvements such as bridge replacements, restroom facilities, or accessible parking.

With generous grant support from the **Spur Community Foundation**, we were able to purchase 4 additional TRAFx infrared trail counters this year and 2 new TRAFx "bike" counters (mountain bikes, e-bikes, and dirt bikes). Using these counters simultaneously, we captured estimates for user group breakdowns at locations like Adams Gulch and Greenhorn.

Looking forward we will continue to collect annual data, build our volunteer ground-truthing program, and explore new ways to grow public trail accessibility through the use of monitoring data. If you want to dive deeper into the data, click **HERE**.



This graph shows the number of counter detections based on each location's average daily traffic rate for the peak season in 2022. Peak season is from Memorial Day to Labor Day. Learn more **HERE.**

★This number is the amount of times someone passed by a counter - meaning someone who went out and back was counted twice. This number is also based off of a selection of trails on the KRD, but it's not exhaustive. We look forward to expanding this program to aid in a deeper, more thorough understanding of total users across all KRD trails.

#### TRAIL STEWARDS PROGRAM

This season we continued our Trail Stewards Program and had seven returning volunteer Trail Bosses. We had Trail Bosses in attendance at all volunteer work parties - taking a more active role with safety and leadership which allowed for larger volunteer events creating greater efficiency and effectiveness.

This past season we worked on establishing the Trail Stewards Program guidelines and systems, as well as refining our training program to align with our partners and national standards for volunteer trail stewards.

Additionally, two of the Trail Bosses were signed off by the Forest Service to work independent of WRTC staff, meaning they will be able to **team lead work parties next season!**

#### MOTORIZED VOLUNTEERS

As always, our local crew of motorized volunteers absolutely crushed it once again - diligently working throughout the season to **keep your trails** clear!

They logged out over **700** trees this season, clearing motorized trails accessed from Deer Creek, Greenhorn, Warm Springs, Baker Creek and more.

The WRTC pays for saw gas, chains and bar oil, along with post-clearing beers and burgers at Lefty's. Thank you to all of the hard working moto volunteers. **We are so grateful for you!**

#### **ADAM'S GULCH**

We partnered with the <u>Sawtooth National Forest - Ketchum Ranger District</u>, the <u>National Forest Foundation</u> and <u>Higher Ground</u> to extend and improve Forbidden Fruit Trail for a better adaptive mountain bike experience, replace or reroute the current trail bridges along Adam's Gulch Trail and improve the current trailhead area.

In the Fall of 2021 the team partnered with <u>Titus Trails</u> to perform extensive maintenance on Forbidden Fruit and to build a mile-long extension. This extension is designed specifically for adaptive mountain bikers, but also provides a fun alternative from Eve's for all riders.

The project is on its final leg this winter, with parking lot improvements and new trail bridges. The project should be completed by the end of June 2023. Watch this short film, **Community Built**, about the project and its importance.



#### FOREST SERVICE PARTNERSHIP

We continue to financially support the Sawtooth National Forest -Ketchum Ranger District trail crew by helping fund wages for seasonal trail crew members. This allows them to spend less time finding funding and more time getting tools in the dirt.

The crew had seven **full-time members** this year. This crew maintains the majority of the 400+ miles of trail surrounding the Wood River Valley, including (but not limited to!) trails accessed from East Fork Road, Corral Creek Road, Lake Creek Road, Baker Creek Road, Fox Creek trailhead, Oregon Gulch trailhead, Adam's Gulch trailhead, Greenhorn and Deer Creek roads.

- 250 miles of trail maintained
- 1,623 downed trees removed from trails
- 38.311 feet of trail brushed


